

39th Annual Algonac Rotary Art Fair

DATE: SATURDAY & SUNDAY, SEPTEMBER 3 & 4, 2011

TIME: 10:00 AM until 6:00 PM Saturday and Sunday, rain or shine. Notice change in times.

Exhibitors must be in attendance both days with sufficient stock to sell.

Booth must be open and intact until 6:00 PM each day.

PLACE: Algonac City Riverfront Park, St. Clair River Drive, Algonac, Michigan

MEDIA: Painting, Mixed Media, Graphics, Printmaking, Photography, Sculpture, Basketry, Clay, Leather, Wood, Glass, Fiber, Jewelry, Enamel, Country Folk, Batik, Floral, Artwear and other original quality artwork. **No kits or commercial products.** All art displayed must be included in your application. Any booth with work not acceptable will be asked to leave, with fees retained as liquidated damages.

RULES OF ENTRY:

Each applicant must submit a minimum of five photographs (including booth) **by June 1, 2011**. Please label all pictures with name, title and material. **The first 50 requests for a Friday night set-up, with a paid application, will be honored.** If you are sharing a booth with another artist, both must submit an application and photographs. **Artists are requested to remove anything of value from your booth.** The committee will not be responsible for loss or damage of any artwork or personal items during the fair.

AWARDS:

Cash prizes and ribbons. Ribbons will be presented the first day of the show, if possible, but prize money will be awarded at the end of the show. Winners must be in attendance both days.

FEE: **Due to the state of the economy we are reducing our booth fee for this year to \$125 if received by June 1, 2011. Booth spaces are 10' x 10' . Fees are non-refundable. Approximately 100 spaces are available. Checks will be cashed upon receipt. Entries received between June 2, 2011 and July 31, 2011 will be charged an additional fee of \$25 for a total of \$150. Entries received between August 1, 2011 and August 15, 2011 will be charged \$200. No applications accepted after August 15, 2011.**

ACCEPTANCE

Notification of acceptance or rejection will be mailed **by June 15, 2011 or before**. A copy of the agreement signed by all parties will be on file at the show. Upon acceptance, fees are non-refundable in the event that the show cannot be held due to weather, acts of God or other circumstances beyond the control of the Algonac Rotary Club and Art Fair Committee.

SET-UP: Each participant must furnish their own set-ups, tables and tents, etc. **Please no tarp-like tents. NO PETS PLEASE OR CARS ALLOWED IN THE PARK.** Check-in time on Saturday will be from 7:00 AM to 9:00 AM. The Algonac Police Department requests that there be **NO DOUBLE PARKING** and that you unload your vehicle completely and proceed to the official parking area before setting up exhibit. Shuttle service will be provided. Report to the Information Booth for location of your exhibit space. **ELECTRICITY IS AVAILABLE.**

SALES: All sales will be transacted and collected by the exhibitor. Each exhibitor is responsible for their own payment of the Michigan State Sales Tax. This park will be used for the sole purpose of selling accepted juried merchandise and for no other purpose.

LIABILITY: The Algonac Rotary Club and Art Fair Committee accepts no responsibility or liability for loss, theft or damage to any exhibitor's property or injury to exhibitors sustained while on the premises of this designated Art Fair or designated parking area. Your signature on this application and lease agreement form constitutes your agreement to the terms and conditions stated herein, and no other terms, conditions or promises shall be binding.
